Panel to assess facilities at AIIMS, Safdarjung

THE DELHI High Court has ordered an assessment of facilities offered at the Centre-run AIIMS and Safdarjung Hospital, on a plea requesting adoption of the premier hospitals' best services in medical institutions run by the Delhi government.

The inspection will be conducted by a seven-member expert committee, who were also asked to survey 35 Delhi government hospitals after it was claimed that state medical facilities were "reeling under... crumbling infrastructure and other glaring infirmities".

The HC order was passed on Delhi government's additional standing counsel Sanjoy Ghose's submission that the aim of the assessment is to ensure that best practices from AIIMS and Safdarjung Hospital, which are operated by the Central government, can also be adopted by the state government, if required.

"He (Ghose) submits that the expert committee may be directed to examine practices adopted by AIIMS and Safdarjung Hospital with regard to services and functioning of the hospitals. Ordered accordingly," a bench of Justice G S Sistani and Justice Anup Jairam Bhambhani said.

The committee was set up after the court was apprised by advocate Prashant Manchanda that Delhi government-run hospitals were in poor shape. This was based on an inspection done in connection with a PIL by a teacher, who lost her nine-month-old foetus when she was admitted to GTB Hospital for delivery.

WAITING FOR a cab in the early hours of Thursday, a 27year-old man was stabbed to death by three men for resisting a robbery. They were arrested five hours later, said police.

The incident took place 100 metres from the victim's house in South West Delhi's Sagarpur, in front of a jewellery shop and a temple. After stabbing the victim, the accused allegedly robbed his phone and wallet before fleeing.

Police said a case under IPC section 302 (murder) has been registered at Sagarpur police station.

In a video of the incident, the victim, Monu Tvagi, is seen surrounded by three men who push him and try to take his backpack. The victim tries to resist and pushes the men. He tries to run but the accused men catch him - one of them holds him and the other two beat him up. Later, one of them pulls out a knife and stabs Tyagi multiple times in the abdomen. He falls



to the ground and the accused take his wallet and phone from his pant pocket. They leave his backpack and flee.

Police said Tyagi was waiting for a cab to go to his hometown in Muzaffarnagar, when the incident took place around

"We received a call around 4.40 am saying that a man was found on the road with stab injuries. Officers rushed to the spot and took the victim to DDU Hospital, where doctors declared him dead on arrival," said Deputy Commissioner of Police (South West) Devender Arya.

Tyagi lived with his cousin, Namit, in Sagarpur.

"He had left early in the morning... he was going to meet his mother and elder brother in

Uttar Pradesh. We were sleeping when a neighbour came and told us that Monu was lying unconscious in the middle of the road. We rushed out and saw Monu on the ground, bleeding from his abdomen. One of the neighbours told us that they saw the accused fleeing," said Namit.

The family alleged that JIGNASASINHA Tvagi's wallet and phone were missing when they found him. "He had Rs 10,000 in his wallet, which he was carrying to give to his mother," said Namit.

Aakash Soni, who owns the jewellery shop outside which the stabbing took place, told The Indian Express: "My family and I were sleeping inside our house, which is next to the shop. Around 4.40 am, we heard a man screaming. I went to the balcony and saw Monu on the ground in front of the shop and a man running away with his wallet. I rushed outside and informed the police."

Police said Tyagi had shifted to Delhi two months ago and worked at a sound-recording company owned by his

### Hours before murder. accused broke into 2 homes, stole phones

TWO HOURS before killing a 27-year-old man whom they robbed, the men arrested for the crime had allegedly stolen three mobile phones from two houses in Dabri and Sagarpur areas of South West Delhi.

Police said the three men were arrested after one of the accused was identified by a beat constable of Sagarpur police station. While two live in Sagarpur, the third lives in Vikaspuri.

"On Thursday, they broke into a house around 12.15 am from where they stole a phone. They later reached Sagarpur, from where they stole two more phones from another house. They were on the lookout for a senior police officer said.

Police said the men were arrested after one of them was identified by a beat constable

### Brandishing guns, 2 men rob customers at bank, steal Rs 8.9 lakh

BRANDISHING THEIR guns inside Central Bank in Shahdara's Farsh Bazaar on Thursday, two men allegedly robbed two customers of Rs 8.9 lakh and fled with the money, said police.

"As they were trying to escape, the bank guard managed to catch one of the accused. Vikas. Police arrested him and recovered the cash from his possession. Vikas told police that he and his associate hail from Amroha in UP. They were in desperate need of money and decided to leave for the capital on Tuesday to rob a bank," said DCP (Shahdara) Amit Sharma.

Police said the other accused

will be arrested soon.

According to police, there were 10 people inside the bank when the accused entered. Two of the customers had bags with cash, which they stole.

During questioning, Vikas told police that they reached Delhi and looked for possible banks to rob. They decided on Central Bank as it had only one security guard stationed outside.

Meanwhile, five more cases of theft and robbery were reported in Shahdara in under three hours on Wednesday.

A total of five people were robbed by unidentified men in Jagatpuri, Farsh Bazaar and Vivek Vihar. No arrests have been made by police in any of
