‘Shocking, police working so negligently’: Court on rape of 4-year-old

A DELHI court on Monday pulled up the Delhi Police while hearing the case of a rape of a four-year-old girl. “The considerable fact is that neither the investigating officer (IO) is present, nor any person on behalf of IO is present, nor despite advance notice any VIR (victim impact report) has been filed. It is shocking that police is working so negligently in such a heinous and sensitive matter,” said Additional Sessions Judge Amit Sahrawat of Rohini court. “Due to the negligence on the part of IO and SHO PS Mahendra Park, the victim and her family cannot be made to suffer, and therefore the proceedings for interim compensation are being taken up without considering the VIR,” he added. The court was hearing the case to decide the interim compensation to be granted to the survivor. “The brief facts of the case are that the victim is just four years old and she has been brutally raped by the accused, due to which the victim’s both private parts got torn and she was admitted to a hospital for 15-16 days,” the court said. “The present offence is so much heinous that although at present victim has been discharged from hospital but still her private parts are not naturally working...,” it added. While pulling up the Delhi Police, the court also said the victim and her family could not be allowed to suffer for the negligence of police officers. It also directed that Rs 5 lakh be disbursed to the child by the Delhi State Legal Services Authority.

LOST IN GOA CLUB FIRE: WIVES, MOTHERS, A BROTHER

‘She’d promised to return by Dec 11, our first anniversary’

ON MONDAY afternoon at the Nigambodh Ghat cremation ground, 30-odd people – friends and relatives – formed a chain to pass along logs of wood from a pile on a cart to the elevated platform where funeral pyres are lit. Four pyres were being prepared side by side – for members of the same extended family. Vinod Kumar, his sisters-in-law Anita Joshi and Saroj Joshi, and his older brother’s wife Kamala were among the 25 people who were killed in the fire that destroyed a nightclub in Arpora village in North Goa past midnight Saturday. Five members of the family, holidaying in Goa since December 2, were dining at the nightclub, Birch By Romeo Lane. Vinod’s wife Bhavana was the only one who survived – Vinod managed to guide her outside before collapsing himself. “Vinod pushed Bhavana out, but then he fainted due to the smoke. He died while trying to save the others. Look at the body... kuchh jalaa nahin hai zyada. Dum ghut gaya uska (the body isn’t burnt, he died of suffocation),” whispered a relative to another. “Zyadatar staff maare gaye hain. Tourist mein yahi the... (Most of those who died were employees, they are the only tourists),” someone else said. “Vivek, Anita’s husband, stood as though numb, staring silently at his wife’s pyre. A bystander asked him gently, “Aap

Naraina mein akele rehthe the? (Did your wife and you stay by yourselves in Naraina?).” “Nahin, iske saath rehta tha. Ab akele rahunga (No, I stayed with her. Now I will stay alone),” replied Vivek. Vivek is 42; Anita was 40. Neither of them had wanted to get married, Vivek said. But they did – only last year. “The Covid-19 pandemic changed everything. I felt that I needed a partner to get through life. Some family friends introduced Anita and me. We sort of dated for a couple of years, and got married last year,” he said. Anita, Vivek said, had told him she would return from Goa before December 11 – what would have been the first anniversary of their wedding. The couple had gone together to Lucknow, Vivek’s home town, on November 28. “After we came back to Delhi, she left for Goa with her sisters. How she loved them...,” he said. Vivek and Anita had planned to be together on their

ED files chargesheet against former minister Satyendar Jain, 13 others

THE ENFORCEMENT Directorate (ED) has filed a chargesheet against former Delhi minister Satyendar Jain and 13 others in connection with a Rs 177-crore corruption case involving the award of four tenders linked to sewage treatment plants (STPs) of the Delhi Jal Board (DJB). The tenders were allotted in 2022 when AAP leader Satyendar Jain was serving as the Water Minister. “The ED has filed a prosecution complaint against 14 persons, including Satyendar Kumar Jain, then Minister of Water, GNCTD and Chairman of DJB; Udit Prakash Rai, then CEO of DJB; Ajay Gupta, then Member of DJB; Satish Chandra Vashishta; then Chief Engineer of DJB; and other private persons/entities under the provisions of the Prevention of Money Laundering Act (PMLA),” an ED spokesperson said in a statement. The statement added that a probe concluded that Kumar

Jain and other accused “are involved in or have assisted in generation, acquisition, concealment, possession and use of total proceeds of crime to the tune of around Rs 17.70 crore and committed offence of money laundering”. The ED started their investigation on the basis of an FIR against Euroteck Environmental Pvt Ltd and others, alleging a fraud in the name of augmentation and upgrade of existing 10 STPs at Pappan Kalan and Nilothi (package 1), Najafgarh and Keshopur (package 2), Coronation Pillar, Narela and Rohini (package 3), and Kondli (package 4). “The probe revealed that one Rajakumar Kurra, Managing Director of M/s EEPL, got the terms and conditions of the DJB tender manipulated through officials of DJB and private persons Nagendra Yadav and others,” the spokesperson alleged. Kurra and others allegedly paid an illegal commission of Rs 6.73 crore, according to the ED. Undue profits of Rs. 9.96 crore were also allegedly made.

AAP alleges vindictive politics, BJP counters

AFTER THE Enforcement Directorate (ED) filed a chargesheet against former Delhi minister and AAP leader Satyendar Jain in an alleged Rs 177 crore Delhi Jal Board (DJB) tender fraud on Monday, a political dust-up was set off between the ruling BJP and the opposition AAP, with both parties trying to frame the chargesheet to its advantage. The AAP dismissed the chargesheet as “another chapter in the BJP’s vindictive politics”. “The Centre and the Delhi government are engaged in vindictive politics. The only party they are afraid of is the AAP,” the party said. The Delhi BJP, meanwhile, termed the chargesheet as proof of the continuous allegations of corruption that the party has levelled against the

previous Arvind Kejriwal-led AAP regime in the Capital. AAP also claimed that Jain had been arrested months before the period cited in the ED’s chargesheet. “ED’s own statement negates the locus standi of this case; it claims the matter pertains to October 2022, even though Satyendar Jain had already been arrested in May 2022 by the ED itself and he was neither Minister in-charge (Water) nor DJB chairman at that time,” it said, also accusing ED of repeatedly seeking extensions “because it has been unable to prove its case”. Delhi BJP president Virendra Sachdeva said, “With the filing of the chargesheet against Satyendar Jain and others in the STP scam, there is now hope that the accused will soon be punished.” He also pointed at the attachment of assets worth Rs 15.36 crore of Jain and other accused in the case.

1 killed, 2 injured as car collides with motorcycle

New Delhi: A 22-year-old man died and two others sustained injuries following a collision between a motorcycle and a car in East Delhi’s Krishna Nagar on Monday, police said. The incident was reported around 4.10 am, they said. Officers said that Sehbaaj, a resident of Khureji who was riding the two-wheeler, was rushed to a hospital but was declared dead. His cousin Sameer, who was riding pillion, is currently undergoing treatment, they said. The driver of the Maruti Swift, identified as Rishabh from Sangam Vihar, was admitted to the hospital with injuries. Another occupant of the car allegedly fled after the crash and is yet to be traced, officers said. Police added that a case has been registered for rash and negligent driving causing death. A probe is underway. ENS

Six arrested a week after robbing businessman of Rs 36 lakh in Mundka

ALMOST A week after a businessman was robbed of Rs 36 lakh in Mundka area of West Delhi, six men were arrested in connection with the case of dacoity, officers said. The accused were identified as Md Irfan (32), Nitesh (35), Aman (21), Manish alias Don (19), Prince alias Awara (19), and Arshad (23), all residents of Delhi and Noida. According to the police, cash worth Rs 10.40 lakh and vehicles and mobile phones purchased with the stolen money were recovered from the accused. “The accused were previously involved in heinous cases, including murder, Arms Act, vehicle theft, and snatching,” DCP (North-West) Bhi-

sham Singh said. According to police, the incident occurred around 7.45 pm on November 28, when complainant Roshan Lal was on his scooter near Mukundpur Flyover, carrying a bag containing cash worth Rs 36 lakh. He was going to hand it over to his firm owner when assailants allegedly intercepted him on two motorcycles. “The pillion rider pushed the victim’s scooter, causing him to fall. One of the accused persons, armed with a knife, assaulted him three-four times, causing injuries on his left hand,” an officer said. The robbers allegedly fled with the bag filled with cash and the victim’s scooter while, he ran for his life. An FIR was registered at Jahangir Puri Police Station, officers said.

The probe revealed that accused Nitesh, who worked as a driver in Gandhi Nagar, had noticed the victim transporting cash regularly. He shared this information with Irfan, who planned the robbery with his associates. The gang allegedly kept a watch on his movement and routes before executing the dacoity, said police. “Officers analysed CCTV

footage and gathered intelligence. Multiple raids were conducted at various suspected hideouts,” officers said. Police said that during the arrests, they recovered Rs 10.40 lakh in cash, one Swift Dzire car, two iPhones valued at Rs 4.15 lakh purchased from the proceeds of crime, the victim’s scooter, and two motorcycles used in the crime.

जापान के उत्तरी तट पर 7.6 तीव्रता के भूकंप से आई सुनामी

टोबो, एपी : जापान में सोमवार को 7.6 तीव्रता का शक्तिशाली भूकंप आया, जिससे क्षेत्र के तटीय इलाकों में सुनामी आ गई। यह भूकंप जापान के मुख्य होंशू द्वीप के सबसे उत्तरी प्रांत आओमोरी के पूर्व में और होक्काइडो द्वीप के दक्षिण में आया। भूकंप का केंद्र आओमोरी प्रांत के तट से 80 किमी दूर और 50 किमी की गहराई पर था। जापानी मौसम विज्ञान एजेंसी ने बताया कि होक्काइडो प्रांत के उराकावा शहर और आओमोरी प्रांत के मुसुओ ओगावाका बंदरगाह पर 40 सेंटीमीटर की सुनामी आई। सार्वजनिक प्रसाक एनएचके की रिपोर्ट के अनुसार, आओमोरी के हाकनोहे शहर के एक होटल में कई लोग घायल हो गए। पीएम साने ताकाइची ने कहा कि नुकसान का तत्काल आकलन करने के लिए एक आपातकालीन कार्रवाई का गठन किया है। परमाणु ऊर्जा संयंत्रों की सुरक्षा जांच की जा रही है।

महिला वकीलों के लिए 30 प्रतिशत सीटें तय हों

नई दिल्ली, प्रे़द़ : सुप्रीम कोर्ट ने सोमवार को निर्देश दिया कि जिन राज्य बार काउंसिलों में अब तक चुनाव प्रक्रिया शुरू नहीं हुई है, वहां 30 प्रतिशत सीटें महिला वकीलों के लिए रखी जाएं। मुख्य न्यायाधीश सूर्यकांत और न्यायमूर्ति जायमाल्या बागची की पीठ ने कहा कि चालू वर्ष के लिए जिन राज्य बार काउंसिलों में चुनाव होने हैं, उन्हें 20 प्रतिशत सीटें महिला उम्मीदवारों से भरनी चाहिए, यदि चुनाव लड़ने के इच्छुक वकील कम हैं, तो 10 प्रतिशत सीटें सह-चयन द्वारा भरी जानी चाहिए। किर्ण न्यायालय ने निर्देश दिया कि जिन राज्य बार काउंसिलों में चुनाव लड़ने वाली महिला वकीलों की संख्या अपर्याप्त है, उनके संबंध में सह-चयन का प्रस्ताव न्यायालय के समक्ष रखा जाए। वरिष्ठ अधिवक्ता मनन कुमार मिश्रा ने पीठ को सूचित किया कि पूर्व निर्देश के अनुसार, चुनाव की अधिसूचना के साथ छह बार निकायों में चुनाव प्रक्रिया शुरू हो गई है।

मैतई विधायक ने कुकी राहत शिविर का दौरा किया
