

## NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR CATERING SERVICE FOR CANTEEN AND MANAGEMENT ACADEMY FOR A PERIOD OF TWO YEARS AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

**Petronet LNG Limited (PLL)**, a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "Catering Service for Canteen and Management Academy for a period of two years" at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no: PLL/DHJ/HR/10923/2025-26.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected:

## **Bid Evaluation Criteria (BEC)**

## A. Financial

- 1. The annual turnover of the bidder shall be minimum INR 2,06,00,000.00 (Indian Rupees Two Crore and Six Lakh Only) in any one of the 03 (three) preceding Audited Financial Years.
- 2. Net worth of the bidder should be positive as per the Balance Sheet of the latest Audited Financial Year.
- **3.** Working Capital of the bidder should be minimum INR 42,00,000.00 (Indian Rupees Forty-Two Lakh Only) as per the Balance Sheet of the latest Audited Financial Year, in the absence of which a line of credit from the Bank shall be submitted.

### B. <u>Technical</u>

- 1. The bidder should have any of the following experience of similar work (\*) in previous 7 (seven) years. The previous 7 (seven) years shall be counted from the last day of bid submission date (Kindly refer Note Point-6).
- (a) One (01) similar contract of value not less than INR 2,06,00,000.00 **OR**
- (b) Two (02) similar contracts of value not less than INR 1,65,00,000.00 each OR
- (c) Three (03) similar contracts of value not less than INR 1,24,00,000.00 each

(\*) Definition of "Similar Work"

"catering, caretaking & housekeeping of Industrial Canteen /Guest house /Management Academy/Academic Institute at least for 2 (two) years"

The Bidder shall submit PO/LOA/Agreement/Work/Service Order copy(ies) and their completion certificate(s) in the support of the above.

The Bidder should have experience of at least 05 (five) years of similar work (\*\*) in previous 7 (seven) years. The previous 07 (seven) years shall be counted from the last day of bid submission date (Kindly refer Note Point-6).



(\*\*) Definition of "Similar Work"

"catering, caretaking & housekeeping of Industrial Canteen /Guest house /Management Academy/Academic Institute"

The Bidder shall submit PO/LOA/Agreement/Work/Service Order copy(ies) (multiples/single) and their completion certificate(s) in the support of the above.

## Note:

Documents in support of Technical Criteria

- 1. The documents in support of the technical criteria shall be duly certified/ attested by Chartered Engineer and Notary public with legible stamp. However, any work/purchase/service order executed for PLL by any Bidder will not require any certification from external parties (i.e. Chartered engineer, notary, or any third-party agency).
- 2. The amount(s) as indicated above shall be exclusive of GST/indirect taxes for arriving at Single/ Two/ Three Completed work order values.
- 3. If the prospective bidder is executing rate / maintenance / service contract which is still running and the contract value / quantity executed prior to due date of bid submission is equal to or more than the minimum prescribed value in the BEC such experience will also be taken in to consideration provided that the bidder has submitted satisfactory work / supply / service execution certificate issued by the end user.
- 4. A job executed by a Bidder for its own plant/projects cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/ fellow subsidiary / Holding company. Such Bidders to submit these documents in addition to the documents specified in the bidding documents to meet BEC.
- 5. In case the work orders submitted by the bidder is in multiple currency/ non-INR, the same shall be converted to equivalent INR considering the conversion rate as on the date of issue of the reference order(s) based on SBI TT selling rate or RBI / Customs Notified exchange rate.
- 6. Even in case the date of bid submission is extended, the date originally considered as reference date for experience criteria, shall remain unchanged.

## **Debit Card**

Bidder has to fill the card details and then he will be redirected to the OTP page on Bank's website. Once he enters the OTP, transaction will be completed successfully, and Bidder will be redirected to Petronet EMD page with Payment confirmation message and receipt.

Simultaneously, a system generated mail will be triggered on Bidder's mail id along with Payment Receipt.

## **Personal Net-banking**

Bidder has to click the Net-banking option and select his bank from the list and click on make payment option. Thereafter Bidder will be redirected to the Bank's Net-banking page and login with his credentials and make the payment. Transaction will be completed successfully, and Bidder will be redirected to Petronet EMD page with Payment confirmation message and receipt.

Simultaneously, a system generated mail will be triggered on Bidder's mail id along with Payment Receipt.

# **Corporate Net-banking**

Bidder has to click the Net-banking option and select his bank's corporate portal from the list and click on make payment option. Thereafter Bidder will be redirected to the Bank's Corporate Net-banking page and login with his credentials and create the Cheque/ RTGS/ NEFT instruction. Bidder will be redirected to Petronet EMD page with Payment awaiting message and a system generated mail will be triggered on Bidder's mail id along with pending payment receipt.

Thereafter as per Bidder's SOP in place, transaction need to be authorised by the approvers on the Corporate Net-banking portal. After approval of transaction by the Bidder, status will be updated in the next 30 minutes on Petronet server and a payment success mail will be triggered on Bidder's mail address.

## b. Challan Payment

If Bidder select challan payment, a unique challan will be generated, and Bidder will be redirected to Petronet EMD page with Payment awaiting message and a system generated mail will be triggered on Bidder's mail id along with challan.

Thereafter Bidder has to make the NEFT/RTGS payment on the account details provided in the challan generated. After processing of transaction by the Bidder, status will be updated in the next 30 minutes on Petronet server, and a payment success mail will be triggered on Bidder's mail address.
