

## NOTIFICATION OF TENDER DOCUMENT FOR GROUP MEDICAL INSURANCE COVER POLICY FOR EXISTING EMPLOYEES AND POST-RETIREMENT MEDICAL POLICY FOR EMPLOYEES SUPERANNUATED FROM SERVICES AT PETRONET LNG LIMITED NEW DELHI

**Petronet LNG Limited**, a company with its registered office at World Trade Centre, 1<sup>st</sup> Floor, Babar Road, Barakhamba Lane, New Delhi, 110 001, India, incorporated in April, 1998 under the provisions of the (Indian) Companies Act, 1956 ("**PLL**" or the "**Company**") and promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOCL**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India. Its shares are listed on the Bombay Stock Exchange and the National Stock Exchange of India

The company invites bids under single stage two-bid system for Group Medical Insurance Cover Policy for Existing Employees and Post-Retirement Medical Policy for Employees Superannuated from the Services at Petronet LNG Limited, New Delhi to submit their bid in accordance with Tender Document (PLLDELHR000582025).

For selection of bidders, Eligibility Criteria is described below. The Bidder should meet the following Techno Commercial Criteria and any Bidder not meeting the same will be rejected.

The interested bidder should meet the following technical and financial qualifying criteria.

2	The bidder must have placed at least one Group Medical Insurance Cover Policy as Insurer, having the following characteristics:  a. Policy period of minimum 12 months; and  b. Minimum Sum Insured of INR 170 Crore; and c. Minimum number of persons insured (including dependents) 3000; and d. Issued in any of the last three financial years (i.e., FY 2022-23, FY 2023-24 & FY 2024-25).	Bidder to submit a copy of the insurance policy on the basis of which qualification sought, duly certified/attested by a Notary Public with a legible stamp.

3	Net worth of the Bidder as on 31st March 2025 must be positive. (Net worth as appearing in the annual accounts of the Bidder shall be considered). (Note: Positive Net Worth criteria is waived for PSU insurance companies considering Ministry of Finance, Office Memorandum dated 5th December 2023) (In case audited financials for FY 2024-2025 is not available as on initial Bid submission date, Net worth of the Bidder as on 31st March 2024 shall be considered).	Bidder to submit Certificate duly certified by Chartered Accountant in Practice in the form attached as <b>Exhibit 2</b> .
4	Gross Direct Premium during any of the last three financial years (i.e., FY 2022-23, FY 2023-24, FY 2024-25) received out of Indian operations from the health segment should be more than INR 170 Crore.	Bidders to submit a certificate from Chartered Accountant in practice as per Exhibit 2.

5	Gross Total Premium during any of the last three financial years (i.e., FY 2022-23, FY 2023-24, FY 2024-25) received out of Indian operations should be more than INR 2,000 Crore. (Gross Total Premium as appearing in the annual accounts shall be considered).	Bidders to submit a certificate from Chartered Accountant in practice as per Exhibit 2.
