

# NOTICE INVITING TENDER (NIT) FOR SUPPLY AND UPGRADATION OF SERVER AND STORAGE AT VARIOUS LOCATIONS OF PETRONET LNG LIMITED.

**Petronet LNG Limited (PLL)**, a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "Supply and Up gradation of Server and Storage at various locations" of Petronet LNG Limited. Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/BIS/7025/2018.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

### **Bid Evaluation Criteria (BEC)**

## Commercial

- 1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 4,50,000/- (Indian Rupees Four Lakh Fifty Thousand only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / nationalized bank.
- 2. The average annual turnover of the Bidder in similar requirement shall be minimum INR 180, 00,000/- (Indian Rupees One Crore Eighty Lakh only) during the financial year 2015-16, 2016-17 and 2017-18. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial year duly certified by statutory auditor of the company.
- 3. Net worth of the Bidder should be positive during preceding financial year.
- 4. The Bidder should have following similar experience during last five years; the last 5 (five) years shall be counted from the last day of bid submission date.
  - a) One (01) similar contract of value not less than INR 170 Lakh; or,
  - b) Two (02) similar contracts of value not less than INR 90 Lakh each; or,
  - c) Three (03) similar contracts of value not less than INR 65 Lakh each; or,

The Bidder shall submit work /service order copy (ies) and their completion certificate(s) in support of the above

#### Technical

1. Only manufacturer(s) of HP Make or their sole authorized distributor / agent are eligible to bid. Updated and valid authorization letter from Original Equipment Manufacturer (OEM) in favor of authorized seller / distributor shall be enclosed along with the techno-commercial bid.
