

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR PROVIDING CAR TRANSPORT SERVICES FOR A PERIOD OF 2 YEARS AT PETRONET LNG LIMITED, KOCHI (KERALA) INDIA

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited ("BPCL"), GAIL (India) Limited ("GAIL"), Indian Oil Corporation Limited ("IOC") and Oil & Natural Gas Corporation Limited ("ONGC"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for Providing Car Transport Services for a Period of Two Years at PLL's Kochi LNG Terminal at Kochi (India). Bids to be submitted in accordance with the Tender Document reference no: **PLL/KOCHI/ADM/SER/3718/2018-19**

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

BID EVALUATION CRITERIA (BEC):

Commercial:

- **1.** The bidder should submit Earnest Money Deposit (EMD) for an amount of Rs. 3,60,000.00 (Rupees Three Lakhs and Sixty Thousand Only) as per Clause-15 of Annexure-IV.
- **2.** The average annual turnover of the Bidder in similar works shall be minimum Rs. 1,50,00,000.00 (Rupees One Crore and Fifty Lakhs Only) during the financial years 2014-15, 2015-16 and 2016-17. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years (2014-15, 2015-16 & 2016-17) duly certified by statutory auditor of the company.
- **3.** Net worth of the Bidder should be positive during preceding financial year i.e. for FY 2016-17.
- **4.** The Bidder should have following experience during last five years, the last 5 (five) years shall be counted from the last day of bid submission date:
- (a) One similar contract of value not less than Rs. 150.00 Lakhs or
- (b) Two similar contracts of value not less than Rs. 80.00 Lakhs each or
- (c) Three similar contracts of value not less than Rs. 60.00 Lakhs each.

Technical:

- 1. Bidder should own at least a fleet of 10 commercial vehicles (cars) of different makes out of which 5 should be in the name of the bidder / Proprietor (documentary evidence in the form of RC Book, Insurance Policy etc. to be submitted).
- **2.** Bidder should have an office in Kerala state (documentary evidence to be submitted).
