



**NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR
FOR COATING OF CONCRETE STRUCTURES
AT PETRONET LNG LIMITED, DAHEJ**

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited (“BPCL”), GAIL (India) Limited (“GAIL”), Indian Oil Corporation Limited (“IOC”) and Oil & Natural Gas Corporation Limited (“ONGC”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for “Coating of Concrete Structures” for PLL’s Dahej LNG Terminal at Gujarat (India). Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/PR/7440/2018.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

Commercial

1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 2,00,000/- (Indian Rupees Two Lakh only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / Nationalized bank.
2. The average annual turnover of the Bidder in similar works shall be minimum INR 125,00,000/- (Indian Rupees One Crore and Twenty Five Lakh only) during the financial year 2015-16, 2016-17 and 2017-18. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
3. Net worth of the Bidder should be positive during preceding financial year.
4. The Bidder should have following similar experience during last five years, the last 5 (five) years shall be counted from the last day of bid submission date.
 - a) One (01) similar contract of value not less than INR 75 lakh or,
 - b) Two (02) similar contracts of value not less than INR 40 lakh each or,
 - c) Three (03) similar contracts of value not less than INR 27 lakh each.
