



**NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR  
CALIBRATION OF 24” ULTRASONIC FLOWMETERS  
AT PETRONET LNG LIMITED, DAHEJ**

**Petronet LNG Limited (PLL)**, a company promoted by Bharat Petroleum Corporation Limited (“BPCL”), GAIL (India) Limited (“GAIL”), Indian Oil Corporation Limited (“IOC”) and Oil & Natural Gas Corporation Limited (“ONGC”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for “**Calibration of 24” Ultrasonic flow meters**” at PLL’s Dahej LNG Terminal at Gujarat (India). Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/IN/7323/2018.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

**Bid Evaluation Criteria (BEC)**

**Commercial**

1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 1,24,000/- (Indian Rupees One Lakh and Twenty Four Thousand only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / Nationalized bank.
2. The average annual turnover of the Bidder in similar works shall be minimum INR 75,00,000/- (Indian Rupees Seventy Five Lakh only) during the financial year 2015-16, 2016-17 and 2017-18 The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
3. Net worth of the Bidder should be positive during preceding financial year.
4. The Bidder should have following similar experience during last five years, the last 5 (five) years shall be counted from the last day of bid submission date.
  - a) One (01) similar contract of value not less than INR 46 lakh or,
  - b) Two (02) similar contracts of value not less than INR 24 lakh each or,
  - c) Three (03) similar contracts of value not less than INR 17 lakh each.

**Technical**

The bidder shall be a regular manufacturer of Ultrasonic Flow meter for custody transfer applications or having experience of similar nature of work. Supporting documents shall be submitted for the same.

The Bidder shall submit work /service order copy (ies) and their completion certificate(s) in support of the above.
