

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR CATERING SERVICE FOR INDUSTRIAL CANTEEN AND MANAGEMENT ACADEMY AT PETRONET LNG LIMITED, DAHEJ

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "Catering Service for Industrial Canteen and Management Academy" at PLL's Dahej LNG Terminal at Gujarat (India). Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/SC/7729/2019.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

Commercial

- 1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 11,00,000/- (Indian Rupees Eleven Lakh only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / Nationalized bank. Firms registered with NSIC will be exempted from payment of Earnest money/Bid Bond provided they are registered upto the monetary limits and for the items they intend to quote against PLL tender.
- 2. The average annual turnover of the Bidder in similar works shall be minimum INR 250,00,000/- (Indian Rupees Two Crore and Fifty Lakh only) during the financial year 2015-16, 2016-17 and 2017-18. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
- 3. Net worth of the Bidder should be positive during preceding financial year.
- 4. The Bidder should have following experience during last five years; the last 5 (five) years shall be counted from the last day of bid submission date.
 - a) One (01) similar contract of value not less than INR 415 lakh or,
 - b) Two (02) similar contracts of value not less than INR 210 lakh each or,
 - c) Three (03) similar contracts of value not less than INR 150 lakh each.

The Bidder shall submit work /service order copy (ies) and / or, their completion certificate(s) in support of the above.

Technical

- 1. Bidder should have at least 5 years' experience in providing similar services i.e running / managing (catering, caretaking & housekeeping) Guest house/Management Academy/Academic Institute.
- 2. Bidder should have experience in handling catering service for minimum 250 employees at a time in one location of an establishment. Bidder should also have experience in maintaining and up keep of at least 15 rooms and other facilities at the same or, any other location of the establishment.
 - Copy of work order / client completion certificate duly notarized must be submitted for verification of technical requirements at Sr. No.1 and 2 above.
- 3. Bidder should have valid food business operator license and registration under rule 31 of Food Safety and Standard Act 2006. The bidder shall submit documents in support of the same.
