



NOTICE INVITING TENDER (NIT) FOR SELECTION OF SUPPLIERS FOR SUPPLY OF GAS AND LEAK DETECTORS AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited (“**BPCL**”), GAIL (India) Limited (“**GAIL**”), Indian Oil Corporation Limited (“**IOC**”) and Oil & Natural Gas Corporation Limited (“**ONGC**”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for “**Supply of Gas and Leak Detectors**” at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/IN/7568/2019.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

Commercial

1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 2,36,000/- (Indian Rupees Two Lakh & Thirty Six Thousand only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / nationalized bank.
2. The average annual turnover of the Bidder in similar works shall be minimum INR 1,48,00,000/- (Indian Rupees One Crore & Forty Eight Lakh only) during the financial year 2015-16, 2016-17 and 2017-18 The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
3. Net worth of the Bidder should be positive during preceding financial year.
4. The Bidder should have following similar experience during last five years, the last 5 (five) years shall be counted from the last day of bid submission date.
 - a) One (01) similar contract of value not less than INR 88 lakh or,
 - b) Two (02) similar contracts of value not less than INR 46 lakh each or,
 - c) Three (03) similar contracts of value not less than INR 31 lakh each.

The Bidder shall submit work /service order copy (ies) and their completion certificate(s) in support of the above.

Technical

1. Bidder shall be manufacturer of the detector. In case of subsidiary/Authorized distributor/Dealer/Integrator/Channel Partner, Bidder shall provide latest valid authorization certification from manufacturer along with technical bid.
2. Bidder should have executed at least one single order for supply of each type of detectors in any of the preceding 05 (Five) years reckoned from final due date of bid submission.

The copies of complete order along with technical specifications and completion certificate shall be attached in technical bid. (The copies of order should contain order number, order quantity, detailed technical specifications). Bidder should attach Performance Certificate from end user.
