

NOTICE INVITING TENDER (NIT) FOR SUPPLY AND INSTALLATION OF 12 INCH ULTRASONIC FLOW METER WITH FLOW PROFILER AND METER RUN AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "Supply and Installation of 12" Ultrasonic flow meter with profiler and meter runs" at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/IN/7378/2019.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

Commercial

- 1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 1,67,000/- (Indian Rupees One Lakh Sixty Seven Thousand only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / nationalized bank.
- 2. The average annual turnover of the Bidder in similar requirement shall be minimum INR 80, 00,000/-(Indian Rupees Eighty Lakh only) during the financial year 2015-16, 2016-17 and 2017-18. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial year duly certified by statutory auditor of the company.
- 3. Net worth of the Bidder should be positive during preceding financial year.
- 4. The Bidder should have following similar experience during last five years; the last 5 (five) years shall be counted from the last day of bid submission date.
 - a) One (01) similar contract of value not less than INR 63 Lakh; or,
 - b) Two (02) similar contracts of value not less than INR 33 Lakh each; or,
 - c) Three (03) similar contracts of value not less than INR 23 Lakh each; or,

The Bidder shall submit work /service order copy (ies) and their completion certificate(s) in support of the above.

Technical

1. The Bidder should be a regular manufacturer of ULTARSONIC FLOW METER for Custody Transfer application suitable for natural gas service as per AGA-9 standard. In case of subsidiary/Authorized distributor/Dealer/Integrator/Channel Partner, Bidder shall provide latest valid authorization certification from manufacturer (confirming the Bidder's status as their authorized/ accredited supplier/ trading house and that the manufacturer as a corporate policy does not quote directly and their offer shall be through authorized/ accredited supplier/ trading house only) along with technical bid.



- 2. The Bidder should have executed at least one single order for design, manufacture, testing, supply and installation of at least 01 no. of USM of minimum 10 inch size & 600# rating for custody transfer services in any of the preceding 05 (Five) years reckoned from final due date of bid submission.
- 3. The Ultrasonic Flow Meter offered by the Bidder shall be from existing range of production with proven track record for satisfactory working since last 5 years. Bidder shall have service network available in India. Bidder to submit the end user performance certificate in support of this.

The copies of complete order along with technical specifications and completion certificate shall be attached in technical bid. (The copies of order should contain order number, order quantity, detailed technical specifications).
