

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR PAINTING INSPECTION SERVICES AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "**Painting Inspection Services**" at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/RC/7884/2019.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

Commercial

- 1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 160,000/- (Rupees One Lakh and Sixty Thousand only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / Nationalized bank.
 - Firms registered with NSIC will be exempted from payment of Earnest money/Bid Bond provided they are registered upto the monetary limits and for items they intend to quote against PLL tender.
- 2. The average annual turnover of the Bidder in similar works shall be minimum INR 45, 00,000/- (Rupees Forty Five Lakh Only) during the financial year 2015-16, 2016-17 and FY2017-18. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
- 3. Net worth of the Bidder should be positive during preceding financial year.
- 4. The bidder should have following similar work experience during last any five years. The last 5 (five) years shall be counted from the last day of bid submission date:
 - a) One (01) similar contract of value not less than INR 60 Lakh or,
 - b) Two (02) similar contracts of value not less than INR 31 Lakh each or,
 - c) Three (03) similar contracts of value not less than INR 22 Lakh each.

The Bidder shall submit LOA / work /service order copy (ies) and / or, their completion certificate(s) in the support of the above.

Technical

1. Painting inspector shall be a qualified graduate engineer or a diploma holder in engineering with NACE CIP level 2 Certification.



2. Inspector shall be 10+ years' experienced Painting Quality Inspector with minimum 2 years in Oil & gas Sector / Fertilizers / Petrochemical sector in running (Operating) Terminal. Inspector shall be experienced Painting Quality Inspector for painting works on offshore platform, jetties, process piping and piping support structures in marine conditions.

Copy of Certificates & Documents supporting afore mentioned requirement to be attached along with offer in techno-commercial bid.
