



**NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR COATING
OF PHASE-II AIR HEATER STRUCTURE AT PETRONET LNG LIMITED, DAHEJ
(GUJARAT) INDIA**

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited (“BPCL”), GAIL (India) Limited (“GAIL”), Indian Oil Corporation Limited (“IOC”) and Oil & Natural Gas Corporation Limited (“ONGC”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for “**COATING OF PHASE-II AIR HEATER STRUCTURE**” at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no: PLL/DHJ/PR/8143/2019.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

A. Commercial

1. The bidder shall submit Earnest Money Deposit (EMD) for an amount of ₹ 3,24,000.00 (Rupees Three Lakhs and Twenty Four Thousand Only) in the form of Online Transfer/Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd., Dahej. Bank Guarantee should be from a scheduled / nationalized bank.
Firms registered with NSIC will be exempted from payment of Earnest money/ Bid Bond provided they are registered upto the monetary limits and for the items they intend to quote against PLL tender.
2. The average annual turnover of the Bidder in similar works shall be minimum ₹ 1,45,00,000.00 (Rupees One Hundred and Forty Five Lakhs Only) during the financial years 2016-17, 2017-18 and 2018-19. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
3. Net worth of the bidder should be positive during the financial year 2018-19.
4. The bidder should have following similar work (*) experience during last seven years. The last 7 (seven) years shall be counted from the last day of bid submission date:-
 - a) One similar contract of value not less than ₹ 122.00 Lakhs or,
 - b) Two similar contracts of value not less than ₹ 63.00 Lakhs each or,
 - c) Three similar contracts of value not less than ₹ 44.00 Lakhs each

The Bidder shall submit LOA/ Work order/Agreement/Service order copy (ies) and their completion certificate(s) in the support of the above.

(*) Definition of “Similar Work”:

Bidder must have successfully completed order of “Supply and Application of Coating/Repair/Retrofitting on concrete structures” in any Department under Central or State Govt. of India / Indian PSU / Government Organization / Private Limited Company / Public Limited Company in previous 07 years reckoned from the due date of bid submission.
