



**NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR
CARRYING OUT SECURITY SERVICES OF EX-SERVICEMEN
(DEFENCE / PARA MILITARY) PERSONNEL
AT PETRONET LNG LTD, KOCHI, (KERALA) INDIA**

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited (“BPCL”), GAIL (India) Limited (“GAIL”), Indian Oil Corporation Limited (“IOC”) and Oil & Natural Gas Corporation Limited (“ONGC”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from prospective bidders for “**Security Services of Ex-servicemen (Defence / Para Military) personnel**” at Petronet LNG Limited-Kochi. Bids to be submitted in accordance with the Tender Document reference no: **PLL/KOCHI/SEC/SER/4608/2019-20**

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

BID EVALUATION CRITERIA (BEC):

Commercial:

1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of Rs. 16,87,000/- (Indian Rupees Sixteen Lakh Eighty Seven Thousand only) in the form of Demand Draft or Bank Guarantee in favour of Petronet LNG Ltd. payable at Kochi. The Bank Guarantee should be from a scheduled / Nationalized bank.
2. The annual turnover of the Bidder shall be minimum of Rs. 3,00,00,000/- (Indian Rupees Three Crore only) during any of the financial year 2016-17, 2017-18 and 2018-19. The Bidder shall submit audited annual financial statements duly signed by statutory auditor for last 3 years.
3. Net worth of the Bidder should be positive during financial year ending 2018-19.
4. The bidder shall have minimum working capital of Rs. 60 Lakh during financial year ending 2018-19. In the absence of minimum working capital, bidder shall provide a letter confirming the availability of line of credit for at least Rs. 60 Lakh from bidder’s bank having Net worth of not less than Rs.100 crore.

Notes:-

- a. The format for “Financial capability of bidder” shall be submitted duly signed and stamped by chartered accountant.
- b. Further, copies of annual audited financial statements shall be submitted duly certified/attested by notary stamp with legible stamp.

Technical:

1. The Bidder should have following similar work experience (**) during last Seven years, the last 7 (Seven) years shall be counted from the last day of bid submission date:

(a) One (01) similar contract of value not less than Rs. 3 Crore;

(**) *Similar Work means - The Bidder should have experience in providing Security Services in Hydrocarbon Sector/Oil & Gas Sector/refineries/PSUs/private organization.*

The Bidder shall submit LOA/work/service order copy(ies) and their completion certificate(s) in support of the above **duly certified/attested by chartered engineer and notary public with legible stamp. A submission of job completion certificate is mandatory.**

2. The Bidder should have employed in any single contract more than one hundred (100) security personnel and should have deployed at least fifty (50) Ex-servicemen from either Army or Navy or Air Force or para military forces during any of the last 3 years i.e. 2016-17, 2017-18 and 2018-19. The Bidder should furnish copy(ies) of work orders in support of the same.

Non-submission of the requisite certificates/documents shall render the bid non-responsive and shall be liable for rejection.
