1) Scope of Work:

Petronet LNG Limited is interested to award a job contract for the security arrangement/ services to be provided at its Kochi Terminal a period of two years and further extendable to one more year at Petronet LNG Limited's sole discretion.

2) Minimum Bid Qualification Criteria:

Few important and mandatory criteria are mentioned below. The tender document contains complete list of Bid Evaluation Criteria.

- 1) The bidder should submit Earnest Money Deposit (EMD) for an amount of Rs. 8,00,000.00/- (Rupees Eight Lakhs Only) in the form of Bank/Demand Draft /Bank Guarantee (as per format attached in the tender documents) in favor of "Petronet LNG Limited, Kochi".
- 2) The consent/approval/license for providing the services as per the complete scope of work provided in the tender document shall be kept valid for the entire duration of the contract and it shall be the sole responsibility of the bidder to maintain/renew the validity of the such consent/approvals there under from time to time, failing which it may lead to cancellation of contract.
- 3) Bidder should have valid License from The Controlling authority of Kerala State as per The Private Security Agencies (Regulation) Act, 2005
- 4) The bidder must have an minimum average annual turnover of Rs. 4,00,00,000.00/- (Rupees Four Crores Only) and should be profit making during the last three years. In this connection bidder are requested to provide copy of the audited balance sheet and profit and loss account for last three financial year ending 31.03.2014.
- 5) The bidder should have during the last five years for providing similar/relevant security services as on 30/11/2014 at least :
 - (a) One running contract of value not less than 4 Crores or
 - (b) Two running contracts of value not less than 2.5 Crores each or
 - (c) Three running contracts of value not less than 2 Crores each.
- 6) The bidder should not been debarred and/or blacklisted by any Central Government / or any State Government Department(s) and the bidder should not have any litigation in any of the labour court(s). An affidavit to that effect on Non-Judicial Stamp paper of Rs. 10/- duly notarized shall be enclosed with the technical bid as per format attached in the tender documents.
