

NOTICE INVITING TENDER (NIT) FOR SUPPLY OF 220/33/11 KV, 50/62.5 MVA TRANSFORMER AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for Supply of 220/33/11 kV, 50/62.5 MVA Transformer at PLL's Dahej LNG Terminal at Gujarat (India). Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/EL/6790/2017.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

Commercial

- 1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 14,00,000/-(Indian Rupees Fourteen Lakh only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / Nationalized bank.
- 2. The average annual turnover of the Bidder in similar requirement shall be minimum INR 9,00,000/- (Indian Rupees Nine Crore only) during the financial year 2014-15, 2015-16 and 2016-17. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial year duly certified by statutory auditor of the company.
- 3. Net worth of the Bidder should be positive during preceding financial year.
- The Bidder should have following experience during last five years, the last 5 (five) years shall be counted from the last day of bid submission date. One (01) similar contract of value not less than INR 7 Crore; or, Two (02) similar contracts of value not less than INR 4 Crore each; or,

The Bidder shall submit work /service order copy (ies) and their completion certificate(s) in support of the above.

Technical

1. Bidder should be a Manufacturer of Power / distribution Transformer and should have supplied one Power / distribution Transformer of minimum 62.5 MVA, 220 / 33 kV voltage class to any of the process plants in Oil & Gas, petrochemical, refinery, fertiliser, power, steel and cement industries in the preceding 07 years as on due date of bid opening.

2. Bidder should have successfully carried out Dynamic Short Circuit Test on any rating of two winding 62.5 MVA, 220 / 33 kV voltage or above transformer in the preceding 07 years as on due date of bid opening and shall enclose the relevant Test Report and Certificate along with bid. The bidder shall provide the test certificate of above test conducted at Recognized Test House or Laboratory/NABL accredited Laboratory.

Documents required to be submitted along with bid in support of Technical Eligibility Criteria:

- a) Copy of company registration certificate/ISO Certificate / NSIC / Excise registration certificate or any other document evidencing the bidder as manufacturer of Power / distribution Transformer.
- b) Copy of Purchase Order along with its proof of execution i.e. execution certificate/completion certificate/payment certificate along with invoice /inspection report etc. issued by the purchaser/end user. The proof of execution should have cross-reference of the purchase order.
