



**NOTIFICATION OF TENDER FOR SELECTION OF CONTRACTOR FOR  
EXECUTION OF BALANCE CIVIL, INTERIOR AND ALLIED WORKS FOR OFFICE  
BUILDING COMPLEX AT DWARKA SECTOR-14, NEW DELHI**

**Petronet LNG Limited**, a company promoted by Bharat Petroleum Corporation Limited (“**BPCL**”), GAIL (India) Limited (“**GAIL**”), Indian Oil Corporation Limited (“**IOC**”) and Oil & Natural Gas Corporation Limited (“**ONGC**”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bid through Domestic Competitive Bidding (DCB) from prospective bidders to submit their qualification proposals in accordance with bidding document (**PLDELPR000122025**), for selection of Contractor for “Balance Civil, Interior and Allied Works for Office Building Complex At Dwarka Sector-14, New Delhi”.

A bid satisfying the requirements of bid eligibility/ evaluation criteria stated herein shall be evaluated for techno-commercial eligibility. Any bid not satisfying the following techno-commercial eligibility criteria shall be liable for rejection:

**1) Technical Criteria/ Details:**

The Bidder shall have experience of successfully executing similar type of Work for an Office/ Hotel/ Data Center/ Commercial building/ Multi-specialty hospital/ Airport terminal building/ Convention Center/ Educational building and following work value in a single project during last ten years, reckoned from the due date for submission of bid:

- (i) One similar completed work costing not less than INR 22.80 crore  
OR
- (ii) Two similar completed works each costing not less than INR 17.10 crore  
OR
- (iii) Three similar completed works each costing not less than INR 11.40 crore

“Similar works” means work related to Interior and Allied works comprising Flooring, False ceiling, Wood work, Partition work, Plumbing, Electrical and works related to Airconditioning, Fire Fighting and activities related to BMS (Building Management System).

The cost of completed works as indicated above is exclusive of GST for arriving at Single/Two/Three completed work order values.

**Notes:**

1. Bidder shall submit the following documents in support of meeting the technical criteria:
  - (a) Copy of LOA/ Work Order with value of work
  - (b) Copy of Work Completion Certificate with executed value of work
  - (c) Copy of relevant document/ BOQ/Scope of work specifying the type of works carried by the bidder
  - (d) If work order / completion certificate does not indicate all requirements of qualification criteria, then Bidder shall submit following document indicating work done:
    - A certificate to this effect from the Owner/ PMC of the work indicating the same  
OR
    - Bill of Quantities (BOQ) certified/ verified by Owner/PMC of the work indicating the above
2. A job executed by a Bidder for its own building/project cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/ fellow subsidiary / Holding company. Such Bidders shall submit these documents in addition to the documents specified in the Bidding Documents to meet BEC.
3. The Bidder shall submit the documents in support of Technical-Bid Eligibility Criteria duly verified and certified by any one of the following independent third-party inspection agencies:
  - i. Société Générale de Surveillance (SGS)
  - ii. Gulf Lloyds Industrial Services (India) Pvt. Ltd. (GLIS)
  - iii. International Certification Services (ICS)
  - iv. Bureau Veritas (Ind.) Pvt. Ltd (BVIS)
  - v. TUV SUD (TUV).
  - vi. Det Norske Veritas (DNV)
  - vii. Certification Engineers International Ltd. (CEIL)
  - viii. Lloyds Register Industrial Services (LRIS)

All charges of the third party for verification and certification shall be borne by the Bidder.

4. Even in case the date of bid submission is extended, the date originally considered as reference date for experience criteria, shall remain unchanged.

**2) Financial Criteria/ Details:**

- 1) **Annual Turnover** - Bidder's minimum Annual Turnover shall be INR 28.50 crore in any one of the preceding three audited financial years i.e. 2021-22, 2022-23, 2023-24.
- 2) **Net Worth** - Net worth of the Bidder as on 31<sup>st</sup> March of previous audited Financial Year i.e. FY 2023-24 should be positive.
- 3) **Working Capital** - Working Capital of the Bidder must be minimum of INR 5.7 crore as on 31<sup>st</sup> March of previous Financial Year i.e. FY 2023-24.

**Notes:**

***Documents in support of Financial Criteria:***

1. *All relevant document submitted in support of financial criteria shall be duly certified by statutory Auditor of the Bidder or Independent Chartered Accountant with his seal/signature and UDIN number.*
2. *If the Bidder is having negative or inadequate working capital, then such Bidder shall submit a letter from any scheduled commercial bank, as per RBI Act, 1934, confirming the availability of the line of credit to cover working capital requirement specified above, as per the format provided in tender document.*
3. *“Net worth” means the aggregate value of the paid-up share capital and all reserves created out of the profits and securities premium account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, as per the audited balance sheet, but does not include reserves created out of revaluation of assets, write-back of depreciation and amalgamation.*
4. *Latest audited financial year shall be reckoned as financial year ending 31<sup>st</sup> March 2024.*
