



**NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR
MAINTENANCE DREDGING OPERATIONS AT PETRONET LNG LIMITED, DAHEJ
(GUJARAT) INDIA**

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited (“BPCL”), GAIL (India) Limited (“GAIL”), Indian Oil Corporation Limited (“IOC”) and Oil & Natural Gas Corporation Limited (“ONGC”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for “**Maintenance Dredging Operations**” at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no: **PLL/DHJ/PO/11089/2025-26**

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected:

Bid Evaluation Criteria (BEC)

A. Financial

1. The annual turnover of the Bidder shall be minimum INR 2,33,00,000.00 (Indian Rupees Two Crore and Thirty-Three Lakh Only) in any one of the 3 (three) preceding Audited Financial Years.
2. Net worth of the bidder should be positive as per the Balance Sheet of the latest Audited Financial Year.
3. Working Capital of the bidder should be minimum INR 46,60,000.00 (Indian Rupees Forty-Six Lakh and Sixty Thousand Only) as per the Balance Sheet of the latest Audited Financial Year, in the absence of which a line of credit from the Bank shall be submitted.

B. Technical

1. The bidder should have any of the following experience of similar work (*) in previous 07 (seven) years. The previous 07 (seven) years shall be counted from the last day of bid submission date (Kindly refer Note Point-6).
 - (a) One (01) similar contract of value not less than INR 2,33,00,000.00 **OR**
 - (b) Two (02) similar contracts of value not less than INR 1,86,40,000.00 each **OR**
 - (c) Three (03) similar contracts of value not less than INR 1,39,80,000.00

(*) Definition of “Similar Work”

“Dredging at one offshore location using Trailer Suction Hopper Dredger (TSHD) to achieve a depth of at least 12 meters below the Chart Datum (CD) under a single contract at a single site”. The experience of only the bidding entity for the above similar work shall be considered for the Bidder’s Qualification Criteria.

The Bidder shall submit PO/LOA/ Work / Service Order copy (ies) and their completion certificate(s) in the support of the above.

Note:

Documents in support of Technical Criteria

1. The documents in support of the technical criteria shall be duly certified/ attested by Chartered Engineer and Notary public with legible stamp. **However, any work/purchase/service order executed for PLL by any Bidder will not require any certification from external parties (i.e. Chartered engineer, notary or any third-party agency).**
2. The amount(s) as indicated above shall be exclusive of GST/indirect taxes for arriving at Single/ Two/ Three Completed work order values.
3. A job executed by a Bidder for its own plant/projects cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/ fellow subsidiary / Holding company. Such Bidders to submit these documents in addition to the documents specified in the bidding documents to meet BEC.
4. In case the work orders submitted by the bidder is in multiple currency/ non-INR, the same shall be converted to equivalent INR considering the conversion rate as on the date of issue of the reference order(s) based on SBI TT selling rate or RBI / Customs Notified exchange rate.
5. Even in case the date of bid submission is extended, the date originally considered as reference date for experience criteria, shall remain unchanged.


