





# Petronet Shares Sink on Investor Unease over New Petchem Plant

CEO defends diversification, says project will generate 19% IRR

New Delhi: Shares of Petronet LNG sank 8.5% on Monday after the company announced a ₹21,000-crore plan to build a petrochemical facility, prompting its CEO to defend the diversification move as the one that would "substantially improve" the finances of the firm.

Petronet's board on Monday gave a green signal to a plan to set up a petrochemical plant as well as propane and ethane handling facilities at Dahej in Gujarat, which already has its largest liquefied natural gas (LNG) import terminal.

"The market should not have any apprehension about its profitability," Petronet LNG's CEOAK Singhtold a news conference. The project would have an internal rate of return of 19%, he added. Investors have been concerned about the returns in the petrochemicals industry given the margin squeeze witnessed in recent times.

Singh said the project has "very little chance of delay" and will benefit from the petrochemicals supply shortfall in the country.





the field of petrochemicals," it added.




