Date - 15 10 23

BMW Management committee meeting was held at Security Conference Room of Petronet LNG Ltd, Dahej.

Following members were present

- 1. Braja Gopal Saha (Mgr), Security
- 2. Mr. Sushil Machi, (Sr Mgr), In charge HSE

The committee met and discussed followed points:

- The Bio medical waste disposal system frequency was reviewed and checked whether
 it was as per established norms of Bio medical waste management rules 2019. On
 inspection of records, it was found that Bio medical waste disposal was within prescribed
 limit of 48 hours.
- ii. Training record on Bio medical waste for staff handling bio medical waste was checked. It was reiterated that training on BMW must also emphasize on safety issues while handling Bio medical waste.
- The license validity of agency handling bio medical waste was checked and it was found valid.
- Field visit was done jointly by the committee members and it was found that the bio medical waste was segregated and stored as per norms in different color coded waste bins. The availability of the bio medical waste management resources was also found adequate.
