Date – 17 May 2024


BMW Management committee meeting was held at Security Conference Room of Petronet LNG Ltd, Dahej.


Following members were present

The committee met and discussed followed points:

- i. The Bio medical waste disposal system frequency was reviewed and checked whether it was as per established norms of Bio medical waste management rules 2019. On inspection of records, it was found that Bio medical waste disposal was within prescribed limit of 48 hours.
- ii. Training record on Bio medical waste for staff handling bio medical waste was checked. It was reiterated that training on BMW must also emphasize on safety issues while handling Bio medical waste.
- iii. The license validity of agency handling bio medical waste was checked and it was found valid.
- iv. Field visit was done jointly by the committee members and it was found that the bio medical waste was segregated and stored as per norms in different color coded waste bins. The availability of the bio medical waste management resources was also found adequate.
- v. Cardboard box with blue marking – Glass vials, ampules, other glass ware is to be discarded in a cardboard box with a blue marking/sticker.

Date - 21/11/2024


BMW Management committee meeting was held at Security Conference Room of Petronet LNG Ltd, Dahej.


Following members were present

The committee met and discussed followed points:

- i. The license validity of OHC for bio medical waste management was checked and it was found that the BMW authorization was till 31/12/2075. The license validity for M/s Globe Bio care, the agency for handling and disposal of Bio medical waste was till 31/12/2024.
- ii. It was reiterated that Occupational safety of all health care workers involved in handling of bio medical waste management must be ensured. Training on BMW must also emphasize on safety issues while handling Bio medical waste.
- iii. During the field visit to the OHC Centre by committee members, it was checked and found that the segregation of waste was as per BMW Rules 2019. On inspection of records, it was found that Bio medical waste handling and disposal was within prescribed limit.
