ABOUT THE COMPANY

Petronet LNG Limited is one of the leading companies in the Indian energy sector. The Company has set up the country's first LNG receiving and regasification terminal at Dahej, Gujarat, and another terminal at Kochi, Kerala. The existing regasification capacity of the Company stands at 22.5 MMTPA with the Dahej Terminal having a nominal capacity of 17.5 MMTPA and the Kochi Terminal having a capacity of 5 MMTPA. Petronet LNG Limited accounts for around 34% of gas supplies in the country and handles around 2/3rd of LNG imports in India.

Petronet LNG Limited is at the forefront of India's all-out national drive to ensure the country's energy security in the years to come with its major expansion plans which includes expansion of regasification capacity of Dahej terminal to 22.5 MMTPA, new greenfield terminal on East Coast of India and a petrochemicals plant at Dahej amongst other projects. The Company was formed as a Joint Venture Company by the Government of India to import LNG and set up LNG terminals in the country, involving India's leading oil and natural gas industry players. Our promoters are GAIL (India) Limited (GAIL), Oil and Natural Gas Corporation Limited (ONGC), Indian Oil Corporation Limited (IOCL) and Bharat Petroleum Corporation Limited (BPCL). The authorized share capital of the Company is Rs. 3000 Crore divided into 300 Crore Equity Shares of Rs. 10 each and paid-up share capital of the Company is Rs. 1500 Crore divided into 150 Crore Equity Shares of Rs. 10 each.







LNG GATEWAY TO INDIA

Largest Long Term LNG Portfolio in India

PLL has set up South East Asia's first LNG receiving, storage and regasification terminal at Dahej, Gujarat in the year 2004.

To cater the gas requirement of Southern India, PLL commissioned its second LNG receiving, storage and regasification terminal at Kochi, Kerala in the year 2013.

Kochi LNG Terminal

Capacity - 5 MMTPA Commissioned in 2013



DRIVING ONWARD

PLL is pursuing approved strategy & vision policy code 1-5-10-40 i.e., to achieve Rs 1 lac Crore turnover and Rs 10,000 Crores PAT with an investment of Rs 40,000 Crores over next 05 years (2022-2027).

Ethane & Propane Storage, Handling and Supply Infrastructure

PLL is developing dedicated storage and handling facilities of 1,70,000 m³ for Ethane and 1,40,000 m³ for Propane as part of its upcoming Petrochemical Complex at Dahej, Gujarat, co-located with the existing 22.5 MMTPA LNG terminal. PLL would be the first in India to offer third-party Ethane storage, handling and sale on a tolling basis. The company is enabling Ethane and Propane supply through multiple logistics modes, including rail, road tankers, and pipelines. PLL has already executed firm contract(s) and is engaged with prospective customers for supply of Ethane and Propane.

Small Scale LNG

LNG Fuel Stations:

PLL commissioned three LNG dispensing stations - Hosur, Irgur, and Namakkal in Tamil Nadu in September 2025 and is set to commission another station at M. K. Hubli, Karnataka, shortly.

Truck Loading Facilities

Dahej Terminal (8 bays) and Kochi Terminal (4 bays) offer Truck Loading facilities enabling sale of LNG to the customers.

LNG Marketing

PLL is one of the largest long-term LNG portfolio holders and largest regasification capacity holder in India. PLL is actively exploring opportunities for LNG marketing and trading in India & overseas.



Petrochemical Complex

PLL has undertaken mega diversification for setting up of Petrochemicals Project of 750 KTPA of PDH and 500 KTPA of PP Plant at Dahej. This state-of-the-art Petrochemical plant is integrated with LNG Terminal and would offer the following products.

1. **Polypropylene (PP):** Supply of 500 KTPA high quality PP homopolymer.
2. **Hydrogen:** Supply of upto 22 KTPA of Hydrogen on term basis.
3. **Propylene:** Supply of Propylene to the customers subject to availability.

LNG Fuel for Fishing Boats

PLL has launched the first fishing boat on LNG Fuel conversion Project at Kochi and is exploring its scalability.

LNG for Mining

To cater the huge energy demand for mining trucks and other transportation in Indian mining sector. PLL is actively engaged with potential consumers for the use of LNG in the mining industry.

PLL's LNG Fleet

The Kochi Terminal is strategically located to serve as a key hub for GUCD operations and LNG bunkering services, offering efficient, reliable and scalable solutions to meet the growing energy and maritime fuel requirements of the region.



LNG Academy - Centre of Excellence

PLL has set up one of its kind of learning center the "LNG Academy (LNGA)" at its Kochi LNG Terminal to impart training on the entire LNG value chain and organise workshops including simulation training to ensure enhancement and updation of knowledge and impart practical hands on experience to the aspirants.




LNG Stations to Promote LNG as Automotive Fuel

PLL is promoting LNG as a clean and cost-effective automotive fuel, offering 20-22% lower CO₂ emissions than diesel with negligible SO_x and PM emissions. Since 2019, LNG dispensing stations and LNG-fuelled buses have been operational at Dahej & Kochi.

LNG Fuel for Inland Waterway Vessels

LNG being a cleaner alternative compared with fuels as FO, LSHS, HSD (Ship Bunkering Fuel), PLL is exploring opportunities to provide LNG for barges or small freight vessels along the National Waterways.



Power Sustainability and Green Initiatives

PLL is strengthening its sustainability and power optimization roadmap through increased adoption of renewable energy. Solar rooftop installations have been commissioned at both Dahej and Kochi terminals. In addition, PLL is actively exploring renewable power sourcing options for its existing LNG terminal as well as the upcoming energy-intensive Petrochemical Complex at Dahej, to ensure sustainable and cost-efficient operations.


Compressed Bio Gas (CBG)

PLL is planning to setup 25 numbers of CBG plants at various locations in different states across India. PLL has initiated pre-project activities at three locations in UP i.e. Baharaich, Kanpur Dehat, and Fatehpur. The following product mix shall be offered:

1. Compressed Bio-Gas (CBG)
2. Fermented Organic Manure (FOM)/Phosphate Rich Organic Manure (PROM)
3. Other by-products like Co₂ and Sulphur



OUR UPCOMING PROJECTS



LNG storage and Regasification project at Gopalpur, Odisha

Envisioning the need of enhanced LNG import infrastructure and also to expand its footprints to the eastern coast in the country, PLL is setting up its third LNG terminal at Gopalpur in Odisha. The land-based LNG Terminal of 5 MMTPA regasification capacity in the east coast of India is expected to be commissioned by 2028.



Regas capacity expansion of Dahej

The capacity of Dahej RLNG terminal, which is the largest terminal in the country, would get further augmented to 22.5 MMTPA from the present capacity of 17.5 MMTPA. This project is in the advanced stage of execution & shall be completed by FY 2025-26.



Third Jetty project at Dahej

PLL's third jetty project at Dahej, designed to enhance terminal reliability, support capacity expansion and enable diversification by handling LNG, liquified ethane and propane, is progressing well. With an overall cost of 2,013 crore and physical progress at ~54%, the project remains on schedule and is expected to be commissioned ahead of the Petrochemical plant.



Petrochemical Complex at Dahej

The Petrochemicals Complex at Dahej, comprising a 750 KTA PDH unit, 500 KTPA PP unit and integrated ethane-propane storage and handling facilities, is progressing well and is targeted to be completed by FY 2028.






