The real heroes are, of course, Tom and Jerry who never miss an opportunity to get into their classic spats, and yet, somehow, still manage to look out for each other in their own ways.

The film struggles to keep your tention as it switches between the human drama and the slapstick comedy with the animated characters. It's a difficult juggling act, and some scenes feel a bit too stretched uto get up to their mischief. Sadly, it's quite a narrative mess, because the characiers are not fleshed out well enough. Very few of them have any redeeming qualities, bespite the cast's best efforts, there's no one to root for, with all the high stakes, twists and turns the fill in throws at its. This holds true for the main character Sue Buttons. There's not a moment when the talented and versatile Allison Janney Isn't capitvating. She commands such a strong presence even when she's meek that you can't take your eyes off her. Sue makes such outlandist decisions at crucial moments that you're left wondering if she deserves to get away with it. With the main plot on thin loe, all the numerous subplots get thinner along with it. An interesting sometimes amusing dynamic between Karl's brother Petey (Jimmi Simpson) and Ria (Wanda Sykes) who owns the store Petey works at, is often glazed over by the sheer number of characters we don't get to know very well.


